March 21st, 2021 - "Progressive Christianity" vs. Progressive Revelation

Last week, I preached about the threat of "Progressive Christianity." One book I read to shed light on the subject was called *"Another Gospel? A Lifelong Christian Seeks Truth in Response to Progressive Christianity"* by Alisa Childers. I recommend this book, and I want to share an excerpt with you about the distinction between "progressive Christianity" and progressive revelation. A progressive Christian might claim God is progressive because He's always revealed more about Himself to people over time. Here's Alisa's response:



"A consistent theme in our class with the progressive pastor was that the earliest Christians represented Christianity in its infancy. The thinking went something like this: we wouldn't expect a brand-new baby to know everything he will know when he's full grown, or to come out of the womb running. First, he must learn to crawl and then to walk. So why would we expect people of a newborn religion to have the same understanding they would have two thousand years later? The pastor explained, 'We are more evolved now. The Bible says the Holy Spirit will lead and guide into all truth...and that's what he's doing.' The implication seemed to be that Paul, Peter, and the other writers of the New Testament represent Christianity in its most primitive form. The Holy Spirit is leading us to do the same work they did...to correct wrong doctrines and perceptions. To hear from God in our time.

This made absolutely no sense to me. On the one hand we do see God revealing more about himself throughout the history of the world. Certainly, Moses had more revelation about God than Abraham did. On the other side of the cross, Paul had a deeper understanding of atonement than the Israelites in the Old Testament did. I would later learn this is what theologians refer to as progressive revelation. It's 'progressive' in the sense that God continued to reveal more information to human beings as time went on. But it doesn't mean that the revelation progressed from error to truth. In this way, there is a huge difference between what theologians have historically meant by progressive revelation and what progressive Christians mean.

The main difference is that the progressive revelation we find in Scripture never contradicts itself, and the revelation of God culminates in Jesus Christ. As Hebrews 1:1-2 gloriously declares, 'Long ago, at many times and in many ways, God spoke to our fathers by the prophets, but in these last days He has spoken to us by His Son, whom He appointed heir of all things, through whom also He created the world.'

In other words, Jesus is God's final word. Progressive revelation is like bricks stacked on top of one another forming a wall of a building. Progressive theology, by contrast, says that we started with the wrong bricks, so we need to remove them and put other ones in — or tear the whole wall down and start over." (p. 136-138)


